**Role of the Institution for Ph.D. (External) Admissions at Institute Level**

- Affiliated college management has to give notification for Ph.D. admission adhering to the University guidelines and regulations in vogue.
- The vacancy position department wise should be certified by Research & Development Cell, JNTUH.
- Maximum of five Ph.D. part time scholars are permitted to each department subject to availability of research supervisors. Not to allot more than one research scholars under any supervisor.
- The applications received by the college through notification should be scrutinized by the University BoS chair person.
- After completion of the scrutiny process, written test has to be conducted by following the University instructions from time to time. For interviews the University nominee is mandatory for selection process.
- The selected list has to sent to the Director, Admissions to obtain the University admission letter, in turn the research scholars has to report at Directorate of Research & Development.
- The admission criteria declared by the University shall be based on the guidelines / norms provided by the UGC and other statutory organisations concerned, as well as any other rules created by the University from time to time.
- The University relevant department shall administer the Ph.D. programme.
- The Ph.D. admissions are usually held annually, generally before the end of August of the every year.
- The registered Research Scholars progress of the research work will be monitored by the Research and Development Cell, JNTUH time to time as per the norms of the University and tuition fee should be paid through online only towards the Registrar JNTUH R&D.
- Through proper channel the supervisors of the Autonomous/Affiliated colleges should communicate progress of the work to Research & Development Cell, JNTUH as per rules framed from time to time.

- Supervisors are not allowed for change of working place of research Institution. If any supervisor is changes his / her working place, in such case University have right to withdraw the recognition of the guideship and research scholars will be allotted to another supervisor working in the University colleges by the Research and Development Cell, JNTUH.
- The Institute has to endorse a list of research facilities available at the College.
- The Research Scholars, who are permitted to join research programme, must pay the prescribed tuition, admission and registration fee as per the University norms.
- During the research period time of JNTUH, the scholar shall not register for any other course, at any other University or Institution, leading to the award of a degree. In the case of any such ambiguity, he/she will forfeit the admission at the JNTUH.
- If a situation arises where there is a conflict between Research Scholar and Supervisor/Co-Supervisor, the decision of University regarding change of Supervisor/Co-Supervisor is final.
- In the case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-Chancellor is final.
- The University reserves the right to alter the regulations from time to time as and when necessary.
- The institution has to maintain adequate separate physical infrastructure for research laboratory.
- Institute shall have Reading Room facilities for researchers with proper furniture and other associated infrastructure facilities.
- Library should have adequate number of books, at least two reputed Journals & online journals (e-Journals) in the concerned subject.
- The institution library shall have requisite number of books in the fields of specialization and shall also be a regular subscriber of national and international journals print version and online journals (e-Journals) for particular' subjects / fields of specialization.
- Availability of broadband internet connection in Research Laboratory/ Library
- Institute has to make necessary arrangement for financial budget provision for research in the Institute's annual budget for its continued maintenance including futuristic expansions.
- **The University shall have the right to withdraw the recognition of the supervisor at any time.**


